LITIGATION TRUSTEE'S MOTION TO APPROVE PROCESS FOR DISTRIBUTION FROM LITIGATION TRUST AND TO APPROVE LITIGATION TRUSTEE AS DISBURSING AGENT

Bettina M. Whyte, as Trustee for the SemGroup Litigation Trust ("Ms. Whyte" or the "Litigation Trustee") files this *Motion to Approve Process for Distribution from Litigation Trust and to Approve Litigation Trustee as Disbursing Agent* (the "Motion"), and respectfully represents to the Court as follows:

#### I. Summary

1. On July 16, 2014 the Litigation Trustee filed her *Motion to Extend Term of Litigation Trust* (Docket No. 9609) (the "Motion to Extend") which was approved by this Court's *Order Approving Litigation Trustee's Motion to Extend Term of Litigation Trust* entered on August 18, 2014 (Docket No. 9619). The Motion to Extend requested a five-year extension of the term of the Litigation Trust<sup>1</sup> to allow the Litigation Trustee time to finalize her recovery efforts and to calculate the resultant corpus of Litigation Trust Interests to be distributed to holders of Allowed Senior Notes Claims (Classes 149-174), Allowed Lender Deficiency Claims (Classes 175-200), and Allowed General Unsecured Claims (Classes 201-226) (each a

"Litigation Trust Beneficiary" and, together, the "Litigation Trust Beneficiaries"). While the completion of the liquidation and distribution process and closing of the Litigation Trust may take several more years, it is the goal of the Litigation Trustee to make an interim distribution to the Litigation Trust Beneficiaries, relying upon this Court's prior approved reserve for those claims which are still in dispute (the "Interim Distribution"). *See*, Order Granting Reorg. Debtors' Reserve Mot. (Docket No. 8477) (the "Reserve Order").

- 2. To accomplish this goal, the Litigation Trustee has reviewed and analyzed claims data and this Court's prior orders, and has coordinated with the Reorganized Debtors, AlixPartners, LLP ("Alix") and Parham Partners LLC ("Parham"). To assist the Litigation Trustee in determining the proper distribution to the Litigation Trust Beneficiaries, Alix has provided claims data, and Parham has assisted as financial advisor in the review of such data.
- 3. The Litigation Trust Beneficiaries are the holders of Allowed Senior Notes Claims (Classes 149-174), Allowed Lender Deficiency Claims (Classes 175-200), and Allowed General Unsecured Claims (Classes 201-226). Pursuant to the terms of the Plan and the Confirmation Order, and as further described herein, the Litigation Trustee will make a distribution equal to 60% of the Interim Distribution to Bank of America, N.A. for the benefit of holders of the Allowed Lender Deficiency Claims; a distribution equal to 30% of the Interim Distribution to HSBC Bank USA NA as Indenture Trustee for the benefit of the holders of the Allowed Senior Notes Claims; and an amount equal to 10% of the Interim Distribution to holders of Allowed General Unsecured Claims.
- 4. Based on the terms of the Order Confirming Debtors' Fourth Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the Bankruptcy Code (Docket No. 6347) (the "Confirmation Order"), the Fourth Amended Joint Plan of Affiliated Debtors Pursuant to

Chapter 11 of the Bankruptcy Code, dated October 27, 2009 (Docket No. 6329) (the "Plan"), and the Litigation Trust Agreement<sup>2</sup> (collectively, the "Plan Documents"), and in addition to other prior orders of this Court related to the claims adjudication process, the Litigation Trustee has developed a distribution process for which she now seeks Court approval (the "Distribution Process"). The key components of the proposed Distribution Process are:

- (i) the method and process for making distributions to each of holders of Allowed Lender Deficiency Claims, Allowed Senior Notes Claims, and Allowed General Unsecured Claims;
- (ii) appointment of the Litigation Trustee as Disbursing Agent and appointment of Alix as Registrar for the holders of Allowed General Unsecured Claims;
- (iii) approval to use October 30, 2009 as the record date for distributions to holders of the Allowed Lender Deficiency Claims and Allowed General Unsecured Claims, pursuant to Paragraph 57 of the Confirmation Order, and November 30, 2009 for holders of Allowed Senior Notes Claims:

and

- (iv) approval of a process for the handling of undeliverable distributions and checks that are not timely negotiated.
- 5. Pursuant to 11 U.S.C. § 1142(b), the Court can make necessary orders to carry out the provisions of the Plan. The Litigation Trustee, as an "entity organized for the purpose of carrying out the plan" has a duty to carry out the terms of the Plan (and the other Plan Documents). 11 U.S.C. § 1142(a). The Litigation Trustee files this Motion seeking Court approval of the Distribution Process as part of her duty to implement the terms of the Plan.

#### II. Background

6. On July 22, 2008 and October 17, 2008 (each a "Petition Date"), SemCrude, L.P. and certain of its affiliates (collectively, the "Debtors") filed voluntary petitions for relief under

chapter 11 of the Bankruptcy Code. On October 28, 2009, the Court entered an *Order Confirming Debtors' Fourth Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the Bankruptcy Code* (Docket No. 6347) (the "Confirmation Order") approving the Plan. The Effective Date of the Plan was November 30, 2009.

- 7. Section 1.78 of the Plan provided for the creation of a Litigation Trust and vested such Litigation Trust with certain assets (as defined in Section 1.80 of the Plan), including interim funding of \$15 million to finance operations of the Litigation Trust, to be repaid to the holders of the Allowed Secured Working Capital Lender Claims. As required by the Plan, \$15 million was distributed to the Agent for holders of the Allowed Secured Working Capital Lender Claims, repaying such claims in full. After repayment to holders of the Allowed Secured Working Capital Lender Claims, the remaining Litigation Trust Interests have continued to be held in trust "for the benefit of holders of Allowed Senior Notes Claims, Allowed Lender Deficiency Claims, and Allowed General Unsecured Claims." Plan ¶ 1.78. The Litigation Trust's purpose is to recover maximum value for the benefit of the Litigation Trust Beneficiaries through the liquidation of assets of the Litigation Trust in accordance with the Plan Documents.
- 8. The assets vested in the Litigation Trust included those Litigation Trust Claims being prosecuted by the Creditors' Committee prior to the Effective Date, and such Causes of Action as set forth in the Plan Supplement filed on October 10, 2009 (Docket No. 6002). Pursuant to Paragraph 11.6 of the Plan, the Litigation Trustee, upon direction by the Litigation Trust Board, has the "absolute right to pursue or not to pursue any and all Litigation Trust Assets

as it determines is in the best interests of the beneficiaries of the Litigation Trust . . . . .  $\P$  11.6(a).

9. Pursuant to the terms of the Litigation Trust Agreement, Ms. Whyte was appointed as the Litigation Trustee by Order Approving Appointment of Litigation Trustee and Litigation Trust Board Pursuant to Fourth Amended Joint Plan of Affiliated Debtors Pursuant to Chapter 11 of the Bankruptcy Code (Docket No. 6474). The Plan Supplement included the form of Litigation Trust Agreement. See, Tab 3, Plan Supplement (Docket No. 6002). In addition to certain causes of action brought in other jurisdictions, beginning in 2010 the Litigation Trustee commenced actions seeking among other things, to avoid and recover preferential transfers and fraudulent conveyances pursuant to Bankruptcy Code sections 547, 548 and 550 (the "Lawsuits"). Since her appointment as Litigation Trustee, Ms. Whyte has prosecuted numerous claims and recovered in excess of one hundred and fifty million dollars of value before payment of related expenses. As of the filing of this Motion, three Lawsuits remain pending – each on appeal. On July 16, 2014 the Litigation Trustee filed the Motion to Extend the term of the Trust to November 30, 2019, which was approved by this Court's Order Approving Litigation Trustee's Motion to Extend Term of Litigation Trust, entered on August 18, 2014 (Docket No. 9619). As stated in the Motion to Extend, it is the goal of the Litigation Trustee to make an Interim Distribution to the Litigation Trust Beneficiaries, using this Court's prior approved reserve (as set out in Docket No. 8477) for those claims which are still in dispute.<sup>5</sup> Ms Whyte believes it is

important to make the Interim Distribution during calendar year 2014. As a result, she intends to use reasonable efforts to make such distribution within fourteen (14) business days after the order approving this Motion becomes final.

- 10. Due to the results to date, and the nearly complete claim objection process (relative to the large number of claims filed), the Litigation Trustee has determined it is appropriate to make the Interim Distribution. Based on the terms of the Plan Documents, in addition to other prior orders of this Court related to the claims adjudication process, the Litigation Trustee has developed a distribution process for which she now seeks Court approval.
- 11. In formulating her Distribution Process, the Litigation Trustee reads the provisions of the Plan Documents together, as required by Paragraph 1.5 of the Litigation Trust Agreement, recognizing that to the extent there is a conflict between or among the provisions of the Litigation Trust Agreement, the Plan or the Confirmation Order, the rank order for the controlling effect of each is (1) the Confirmation Order, (2) the Plan, and (3) the Litigation Trust Agreement. Lit. Trust Agmt. ¶ 1.5; Conf. Order ¶ 60.

#### III. Relief Requested

12. The goal of the Litigation Trustee always has been to distribute the Litigation Trust Interests to the Litigation Trust Beneficiaries in an orderly and efficient manner. As a result of the substantial completion of the claims administration process and the liquidation of the Litigation Trust Interests, the Litigation Trustee now requests Court approval of the Distribution Process set forth in this Motion.

#### (A) Disbursing Agent and Registrar.

extended the time period for the Reorganized Debtors to file and serve objections to claims through and including November 17, 2014, without prejudice to the right of the Reorganized Debtors to seek additional time.

- Debtors or such other Entity as may be designated in the Confirmation Order." Plan ¶ 1.41. No other Entity has been named Disbursing Agent in the Confirmation Order. Thus, the Reorganized Debtors are the Disbursing Agent. Per the terms of the Litigation Trust Agreement, "[a]ll distributions to be made by the Litigation Trustee hereunder to the holders of the Litigation Trust Interests shall be made to the Disbursing Agent for further distribution to the holders of the Litigation Trust Interests in accordance with the Plan . . . ." Lit. Trust Agmt. ¶ 6.2(a).
- 14. Paragraph 13.1(c) of the Plan provides that the Reorganized Debtors, as Disbursing Agent, are to make distributions of New Common Stock and Warrants, but not cash. All distributions by the Litigation Trustee will be cash. The Litigation Trustee has consulted the Reorganized Debtors, and the Reorganized Debtors and the Litigation Trustee are in agreement that, for the limited purpose of making cash distributions to the Litigation Trust Beneficiaries, as set forth herein, the Litigation Trustee should be designated as the Disbursing Agent. The Litigation Trustee is better suited than the Reorganized Debtors to make distributions, as set forth herein, to the Litigation Trust Beneficiaries. For the limited purpose of disbursing the Litigation Trust Interests, as set forth herein, the Litigation Trustee requests that she be appointed the Disbursing Agent with the rights and powers set forth in Paragraphs 14.1 and 14.3 of the Plan.
- 15. Pursuant to Paragraph 2.5(b) of the Litigation Trust Agreement, the Litigation Trustee has appointed Alix as Registrar for purposes of recording ownership and other information, such as postal address, to holders of Allowed General Unsecured Claims. Alix has established a monitored hotline, which is 1-888-363-0091, where a message can be left regarding questions related to Allowed General Unsecured Claims.

#### **(B) Record Date.**

- 16. The Litigation Trust Beneficiaries are the holders of Allowed Senior Notes Claims (Classes 149-174), Allowed Lender Deficiency Claims (Classes 175-200), and Allowed General Unsecured Claims (Classes 201-226). Confirmation Order ¶ 57.
  - 17. Paragraph 2.5(a) of the Litigation Trust Agreement states:
    - 2.5 No Transfers.
    - (a) No transfer, sale [sic] assignment, distribution, exchange, pledge, hypothecation, mortgage or other disposition (each, a "Transfer") of a Litigation Trust Interest or any entitlement of a holder of a Secured Working Capital Lender Claim hereunder may be effected or made; provided, that, Transfers of Litigation Trust Interests or entitlements of a holder of a Secured Working Capital Lender Claim hereunder and/or under the Plan may be made by operation of law or by will or the laws of descent and distribution.
- 18. The Litigation Trust Agreement's "No Transfer" provision is effective as of the Effective Date of the Litigation Trust Agreement, which is the Effective Date of the Plan -November 30, 2009. Therefore, the Litigation Trustee seeks Court approval of a process for making distributions, including the Interim Distribution, to holders of the Allowed Senior Notes Claims as of the Effective Date of the Plan, November 30, 2009 (the "Allowed SNC Record Date").
- 19. The Confirmation Order does not specifically address the record date for holders of Allowed Senior Notes Claims. Plan ¶1.131. The Litigation Trust Agreement is at Tab 3 to the Plan Supplement. The Plan Supplement was approved and incorporated into the Confirmation Order. See, Confirmation Order ¶ 1.
- 20. Paragraph 57 of the Confirmation Order provides that the Record Date with respect to the purpose of determining the holders of Allowed Claims entitled to receive distributions pursuant to the Fourth Amended Plan in Classes 175 through 226 shall be October 30, 2009. Classes 175 through 226 include the Allowed Lender Deficiency Claims and the

Allowed General Unsecured Claims. Therefore, the Litigation Trustee seeks Court approval of a process for making distributions, including the Interim Distribution, to holders of the Allowed Lender Deficiency Claims and Allowed General Unsecured Claims as of October 30, 2009 (the "Allowed LDC and Allowed GUC Record Date").

#### (C) Reserve Amounts for Unliquidated General Unsecured Claims.

21. The aggregate allowed amounts of the Allowed Senior Notes Claims and the Allowed Lender Deficiency Claims are fixed. In the Reserve Order, the Court approved the process undertaken by the Reorganized Debtors to estimate claims. As to those Allowed General Unsecured Claims that either were not contingent, unliquidated or disputed, or that have been resolved, the Trustee will use the scheduled or resolved amounts, as applicable. As to those Allowed General Unsecured Claims that remain contingent, unliquidated, or disputed, the Litigation Trustee seeks authorization to use the reserve amounts approved by the Court for the remaining General Unsecured Claims in determining the percentage distribution to each holder of an Allowed General Unsecured Claim.

#### (D) Distributions.

- 22. All distributions to holders of Allowed General Unsecured Claims will be made, at the Litigation Trustee's discretion, by either wire transfer or check and all distributions to holders of Allowed Senior Notes Claims and Allowed Lender Deficiency Claims will be made by wire transfer, in accordance with Paragraph 13.4 of the Plan.
- 23. All distributions made by the Litigation Trustee will be made to holders of Allowed Litigation Trust Claims as follows:
  - (a) Allowed Senior Notes Claims. As to holders, as of November 30, 2009, of Allowed Senior Notes Claims, the Litigation Trustee will send a single distribution by wire transfer to HSBC Bank USA NA, [in its capacity as Successor Indenture Trustee under the Indenture dated as of November 18, 2005, as supplemented] Corporate Trust and Loan Agency, 10 E. 40th Street, 14th

Floor, New York, New York 10016 (the "Allowed Senior Notes Claimants Indenture Trustee"). The Allowed Senior Notes Claimants Indenture Trustee shall make further distributions within fourteen (14) business days after receipt of the single distribution from the Litigation Trustee to the holders of the Allowed Senior Notes Claims in accordance with the Plan, and pursuant to the terms and provisions of the Indenture dated as of November 18, 2005, as supplemented.

- (b) Allowed Lender Deficiency Claims. As to holders, as of October 30, 2009, of Allowed Lender Deficiency Claims, the Litigation Trustee will send a single distribution by wire transfer to Bank of America, N.A. [in its capacity as administrative agent for the benefit of the holders of the Allowed Secured Working Capital Lender Claims], Attention: Credit Services/RPILAND Ref: Semcrude (the "Allowed Lender Deficiency Claims Agent"). The Allowed Lender Deficiency Claims Agent shall make further distributions within fourteen (14) business days after receipt of the single distribution from the Litigation Trustee in accordance with the Plan.
- Allowed General Unsecured Claims. As to holders, as of October 30, 2009, of Allowed General Unsecured Claims and unless otherwise agreed among the Litigation Trustee, Alix, and the holder of the Allowed General Unsecured Claim to which the payment is being sent, the distributions shall be made at the addresses provided to the Litigation Trustee by Alix. These addresses shall be certified by Alix as those set forth on the Schedules filed with the Bankruptcy Court unless superseded by the address set forth on proofs of claim filed by such holders, or at the last known address of such holders if no proof of claim is filed or if notice was provided in writing of a change of address, in accordance with Paragraph 13.5 of the Plan or in response to this Motion to Henry Colvin at AlixPartners, LLP Attn: SemGroup Litigation Trust Distribution, at 2101 Cedar Springs Road, Suite 1100, Dallas, TX, 75201, Tel.: 1-888-363-0091, Fax: 214-647-7501. The Litigation Trustee shall have the authority to rely fully upon the addresses provided to the Litigation Trustee by Alix or as agreed among the Litigation Trustee, Alix, and the holder of the Allowed General Unsecured Claim to which the payment is being sent, and shall have no duty to attempt to locate any holder of an Allowed General Unsecured Claim.

For purposes of the Interim Distribution, the percentage of the distribution to each Allowed General Unsecured Claim shall be made in accordance with the Allowed General Unsecured Claims Registry, attached hereto as <a href="Exhibit 1">Exhibit 1</a>. The distribution amount shall be based on the allowed claim amount for each holder of the Allowed General Unsecured Claim or, as to the CUD General Unsecured Claims, as such term is defined in the Reserve Order, that continue to be contingent, unliquidated, or disputed, the maximum limitation set by the Court in the Reserve Order.

- (i) In accordance with the Plan, the Litigation Trustee will make no single distribution in an amount less than \$100.00 to any holder of a Litigation Trust Interest <sup>6</sup>
- (ii) As required by the Court's Second Order With Respect to Compromise and Settlement with SemGroup Energy Partners, L.P. (Docket No. 3647 [Ref. 3315]), the Litigation Trustee will make distributions to Blueknight Energy Partners (f/k/a SemGroup Energy Partners, L.P. ("SGLP")) (the "Blueknight Distribution").
- (iii) As required by the Court's Order Approving Settlement and Release Agreement Between SemGroup Holdings, L.P. and Manchester Securities Corp. (Docket No. 383, Case No. 08-12504) (the "Manchester Settlement"), the Litigation Trustee will make distributions on account of the Manchester Settlement directly to Manchester Securities Corp. as set forth in Claim No. 5979 filed in Case No. 08-12504 (the "Manchester Distribution").
- (iv) The Litigation Trustee shall make no distribution on account of any Intercompany Claim, as such term is defined in the Plan. Neither the Blueknight Distribution and the Manchester Distribution are Intercompany Claims, as such term is described in the Plan, as neither SGLP nor SemGroup Holdings, L.P. were jointly administered debtors in *In re SemCrude, L.P. et al.*, Bankruptcy Case No. 08-11525 (BLS).
- 24. If a distribution to any holder is returned as undeliverable, no further distributions shall be made to such holder unless and until Alix, as Registrar, or the Litigation Trustee is notified by such holder or such holder's agent or representative, in writing, of such holder's thencurrent address. Undeliverable distributions shall remain in the possession of the Litigation Trustee until such time as the distribution becomes deliverable or until such holder fails to claim the undeliverable distribution as set forth herein. A holder shall be deemed to have failed to claim an undeliverable distribution 180 days after such undeliverable distribution is made pursuant to the Distribution Process set forth herein, if such distribution is a final distribution, at

which point such holder shall have its entitlement to such undeliverable distribution discharged and shall be forever barred from asserting any entitlement to such distribution or otherwise pursuant to the Plan against the Litigation Trust. In such case, any consideration held by the Litigation Trustee for distribution on account of an undeliverable distribution shall be held, and made with the final distribution to the Litigation Trust Beneficiaries. Nothing shall require the Litigation Trustee to attempt to locate any holder of an Allowed Claim. Any and all Entities, as such term is defined in the Plan, including holders of an Allowed Senior Notes Claim, an Allowed Lender Deficiency Claim or an Allowed General Unsecured Claim shall not be entitled to any interests or other accruals of any kind.

- 25. Checks issued by the Litigation Trustee on account of the holders of Allowed General Unsecured Claims shall be null and void if not negotiated within 180 days from and after the date of issuance thereof. The Litigation Trustee shall have no obligation to re-issue any check so voided unless a request for re-issuance is made in writing to the Litigation Trustee on or before 180 days before the Litigation Trustee makes a final distribution.
- 26. The provisions of the Plan Documents that are applicable to the Litigation Trust, the Litigation Trustee, or the Litigation Trust Interests shall govern unless otherwise addressed herein.
- 27. The Litigation Trustee will use reasonable efforts to make the Interim Distribution within fourteen (14) business days after this Order becomes final and non-appealable.

#### (E) Notice.

28. The Litigation Trustee seeks Court approval of the *Notice of Filing of Litigation*Trustee's Motion to Approve Process for Distribution From Litigation Trust and to Approve

Litigation Trustee as Disbursing Agent (the "Notice"), attached hereto as Exhibit 2, which will

be served (i) upon the Allowed Senior Notes Claimants Indenture Trustee and the Allowed Lender Deficiency Claims Agent, as such terms are defined herein, (ii) to the holders of Allowed General Unsecured Claims as listed on Exhibit 1 attached hereto, (iii) to the remaining holders of Allowed General Unsecured Claim (that are not likely to receive an Interim Distribution), and (iv) by publication in the *Wall Street Journal*, *USA Today*, *The Houston Chronicle*, *Tulsa World*, and *The Oklahoman*. The Motion and related documents will also be served upon those parties listed on the 2002 Service List.

#### IV. Basis for Relief

- 29. The Bankruptcy Code, this Court's prior orders, and the Plan Documents authorize the Litigation Trustee to make the Interim Distribution pursuant to the Interim Distribution Process proposed in this Motion.
- 30. Sections 105 and 1142(b) of the Bankruptcy Code, together with Bankruptcy Rules 3020(d) and 3021, authorize this Court to enter an order authorizing and approving the Interim Distribution Process. *See generally, In re Jorgensen*, 66 Bankr. 104, 108 (9th Cir. BAP 1986) ("The court under §§ 105 and 1142(b) can make necessary orders to carry out the provisions of the plan."); *see also, In re Johns-Manville Corp.*, 97 B.R. 174, 180 (Bankr. S.D.N.Y. 1989). Section 105(a) of the Bankruptcy Code authorizes this Court to "issue any order, process or judgment that is necessary to carry out the provisions of [the Bankruptcy Code]." With respect to implementation of the Plan Section 1142(b) of the Bankruptcy Code provides:
  - (b) The court may direct the debtor and any other necessary party to execute or deliver or to join in the execution or delivery of any instrument required to effect a transfer of property dealt with by a confirmed plan, and to perform any other act, [119] including the satisfaction of any lien, that is necessary for the consummation of the plan.

11 U.S.C. § 1142(b)

31. The clear intent of this section is for a bankruptcy court to retain its jurisdiction to assure that the terms and provisions of a confirmed Chapter 11 plan are carried out until the plan is completed and a final decree is entered closing the case. Bankruptcy Rule 3020(d) provides that "notwithstanding the entry of the order of confirmation, the court may issue any other order necessary to administer the estate." Bankruptcy Rule 3021 states:

Except as provided in Rule 3020(e), after a plan is confirmed, distribution shall be made to creditors whose claims have been allowed, to interest holders whose interests have not been disallowed, and to indenture trustees who have filed claims under Rule 3003(c)(5) that have been allowed. For purposes of this rule, creditors include holders of bonds, debentures, notes, and other debt securities, and interest holders include the holders of stock and other equity securities, of record at the time of commencement of distribution, unless a different time is fixed by the plan or the order confirming the plan.

Fed. R. Bankr. P. 3021

Accordingly, this Court retains jurisdiction on a continuing basis to oversee those responsible for implementation of the Plan, including the Litigation Trustee, and to enter appropriate orders to enforce the intent and specific provisions of the Plan.

32. 11 U.S.C. § 1142(a) requires the debtor and any entity organized or to be organized for the purpose of carrying out the plan to "carry out the plan" and comply with any orders of the court." 11 U.S.C. 1142(a). The Litigation Trust is an entity organized for purposes of carrying out the Plan, and the Litigation Trustee is charged with administering the Litigation Trust Assets. The terms of the Litigation Trust Agreement, which is incorporated into the Plan pursuant to the Plan Supplement, states that one of the purposes of the Litigation Trust is to "oversee and direct the expeditious but orderly liquidation of the assets of the Litigation Trust." Lit. Trust Agmt. ¶ 1.4(a). The "Litigation Trustee, upon direction of the Litigation Trust Board, and the exercise of their collective reasonable business judgment" is required to convert to cash

the Litigation Trust Assets, make timely distributions and not unduly prolong the duration of the Litigation Trust. Lit. Trust Agmt. ¶ 1.4(b).

- 33. Bankruptcy courts retain jurisdiction on a continuing basis to oversee those responsible for implementation of a confirmed plan, and to enter appropriate orders to enforce intent and specific provisions of a plan, including an order authorizing and approving distributions. *See*, *e.g. In re Resorts Int'l*, *199 B.R. 113*, *119* (Bankr. D.N.J. 1996).
- On June 13, 2014 the Reorganized Debtors filed the *Reorganized Debtors' Motion Pursuant to Sections 105(a) and 1129 of the Bankruptcy Code Extending the Time Period to File and Serve Objections to Claims* (Docket No. 9598) (the "Motion to Extend Claim Objection Deadline"). As of that date, the Reorganized Debtors indicated that there are nine (9) unresolved claims filed by general unsecured creditors. Mot. to Extend Claims Obj. Deadline ¶ 9. At least one of these unresolved claims has been resolved since the filing of the Motion to Extend Claim Objection Deadline. *See*, Stipulation Regarding Claim of Kinder Morgan Liquid Terminals LLC (Docket No. 9615-1) and, upon information and belief, several other claims have been resolved or are close to resolution.
- 35. The Reorganized Debtors have stated that although there are only a few objections to General Unsecured Claims remaining, it will require time to finally resolve them due to the complexity of the outstanding claims. The remaining claims "are those that involve significant disagreements between the Reorganized Debtors and the claimant" and it is possible (perhaps even likely) that resolution will be reached only through litigation. Mot. to Extend Claims Obj. Deadline ¶ 13. The Litigation Trustee has only three Lawsuits that remain pending. Given the nature of the appellate process, years could pass before those Lawsuits are fully and finally resolved. Because the Litigation Trustee will make distributions of the Litigation Trust

Interests on a percentage basis, the process of determining the full amount to be distributed to each claimant is dependent on the final resolution of all the Lawsuits and all Allowed General Unsecured Claims. Rather than delay making any distributions until resolution of these issues, the relief requested in this Motion is an exercise of the Litigation Trustee's duties to make timely distributions and not unduly prolong the duration of the Litigation Trust.

- 36. The allowed amounts for the Allowed Senior Notes Claims and the Allowed Lender Deficiency Claims are fixed. The component of the Interim Distribution that is most variable is that of the Allowed General Unsecured Claims. In its Reserve Order, the Court already has approved the process undertaken by the Reorganized Debtors to estimate claims, which forms the basis for the Litigation Trustee's distributions. Thus, the Litigation Trustee proposes to use the reserve amounts approved by the Court for the remaining unresolved CUD General Unsecured Claims<sup>7</sup> in determining the percentage distribution to each holder of the Allowed General Unsecured Claims in the Interim Distribution.
- 37. Approval of the Distribution Process as outlined in this Motion will best serve the goal of an expeditious administration of the Litigation Trust Interests, while also reserving sufficient funds to continue the necessary administration until the process of liquidating and distributing all of the Litigation Trust Interests can be completed.
